Madrid Protocol fees revised for San Marino

Unregistered trademarks outside courts' purview, rules Argentine court

On 16 September 2024, the Federal Court of Appeals in Civil and Commercial Matters of Argentina, in the Terrawind Reps SA de CV v. Maria del Pilar Lozano Mancipe case, affirmed a lower court's decision, concluding that it lacked jurisdiction to hear the cancellation of several trademark applications filed by Terrawind Reps SA de CV.

WIPO releases 2025 version of 12th edition of Nice Classification

The 2025 version of the 12th edition of the International Classification of Goods and Services for the Purposes of the Registration of Marks (Nice Classification) released by the World Intellectual Property Organization (WIPO) will enter into force on 1 January 2025, and the International Bureau (IB) of the WIPO will start applying the new version to all applications for international registration received on or after that date.
